I. Tuition/Fees

1. I, the undersigned, understand that my child's enrollment at All Angels Academy is for the period of one full academic year ending in June, 2018. The undersigned acknowledges that All Angels Academy is relying upon this commitment in reserving enrollment for my child for the entire academic year, and confirms my responsibility for the payment of a full year's tuition and all other charges for that academic year. In the event my child withdraws from or otherwise cancels enrollment at All Angels Academy at any time after the execution of this contract and prior to the conclusion of the academic year, full tuition and all applicable charges for that academic year shall remain due and payable to All Angels Academy as fully earned.

2. Fees and tuition payments are not refundable.

3. Tuition is due in full June 1, 2018. Tuition is payable in ten monthly payments. The first payment is due August 1, 2017. Payments two through ten are due on the first of each month, beginning in September, 2017 and ending May, 2018. In addition, the supply fee, the technology fee, and the athletic fee are due on or before July 1, 2017.

4. I understand and agree with the School's policy that all accounts must be paid in full before any and all records, yearbooks, grade reports, and transcripts will be released to parents or transferred to other schools. I further understand that my child will not be allowed to continue to attend classes, take examinations, or participate in school-sponsored activities when tuition and fees are more than 30 days past due. The School shall also have the right to take such legal action as it may deem appropriate to collect all amounts which are not paid when due. In the event the school takes legal action in enforcing performance or collection of this Contract, I will

be responsible for all costs, including reasonable attorney's fees and costs (whether incurred before, during, or after the filing of a lawsuit).

5. I, the undersigned, am responsible for the care of any books issued or borrowed from the school and agree to pay the costs of any that are lost or damaged.

## II. Publicity Release

1. I, the undersigned, understand that there are many occasions in which the school would like to showcase the students. I agree to allow my child's photograph to be used by the School in the School's publications, promotional materials and website, without compensation and without prior notice. I hereby release and hold the school harmless from any liability stemming from the use of the child's photograph. I also allow the School to use the child's name in press releases and articles.

2. I, the undersigned, authorize the School to publish family information in the Student Directory, which includes family names, addresses, telephone numbers, e-mail addresses, and grade levels. I further understand that the School directory is solely for the private use of School Families and staff members for the communications among School constituents in furtherance of the School's mission, goals, and accomplishment of its educational purpose as determined by the School. I understand that violation of this paragraph may result in the child's dismissal from School.

## III. Activity and Medical Release

Having been informed of the supervised activity and education for the student, I, the undersigned, give my approval for his/her participation in any and all of the activities. I assume all risks and hazards incidental to the conduct of the activity, and do further hereby release, absolve, indemnify, and hold harmless All Angels Academy, its agents, employees, the organizers, and the sponsors, any and all of them, unless extreme negligence has been involved. In case of injury to the student, I hereby waive all claims against the organizers, the sponsors, or any of the supervisors appointed by them.

In the event the student becomes ill or is injured while under school supervision, I approve the school authorities to take the following steps:

1. Contact a parent of the student and follow his/her instructions.

2. If neither of the parents can be reached, the school will then contact the emergency numbers given by the parent. If no one is available to respond, the school will contact emergency services.

3. If the circumstances are more serious in nature, I agree that the School may contact emergency services first.

#### IV. Statement of Cooperation

I, the undersigned, agree:

1. The information given on the registration form is accurate to the best of my knowledge. I understand that incomplete or withheld information may disqualify the Student for admission or may, after admission, be a basis for the Student's dismissal.

2. That a positive and constructive working relationship between the School and family is essential to the fulfillment of the School's educational purpose. Thus, I understand that the School reserves the right not to extend the privilege of enrollment or re-enrollment to a child if the School reasonably concludes that the actions of a parent or family member make such a positive and constructive relationship impossible or otherwise seriously interferes with the School's decisions, policies, and accomplishment of its educational purpose. If any family member engages in behavior, communications or interactions on or off campus, that is disruptive, intimidating, overly aggressive, or reflects a loss of confidence in or disagreement with the School's policies, methods of instruction or discipline, or otherwise interferes with the School's safety procedures, responsibilities or accomplishment of its educational purpose or program, the School reserves the right to dismiss the family. Any determination under this paragraph shall be in the School's sole discretion. There will be no refund of tuition where such dismissal occurs and any unpaid balance is payable in full according to the terms of this Contract. The School also reserves the right to withdraw an offer of enrollment or re-enrollment at any time and to void an executed Enrollment Contract.

3. To pay all my financial obligations on or before the date due and adhere to the school's tuition policies.

4. To fulfill my obligation to insure that my child is dressed in compliance with the established uniform code as outlined in the Parent/Student Handbook.
